DRÍVING CROSSCUT TO STANDARD VEIN

C. H. D. Douglass of Yakima in Charge of Work, Has Comprehensive Program of Work.

The Grande Ronde Mines, Inc., is getting well under way in its program of developing a large group of mining claims near the headwaters of the Grande Ronde river northwest of Baker. C. H. D. Douglass, of Yakima, Wash., who is heavily interested in the company, is in charge of the work. Mr. Douglass is a frequent visitor in Baker coming here to purchase supplies for the camp.

the work is being centered on completing the lower crosscut to the Standard vein. He figures the tunnel is nearing the vein and expects to break into it any day. This tunnel will cut the ledge at a depth of approximately 250 feet on the dip.

The Grande Ronde company takes in properties formerly known as the Aurelia and the Standard. There are several known veins on the ground. The Standard veins and Aurelia have been traced upward of 2000 feet by surface cuts and openings. There has been considerable development by tunnel and there has been some high grade ore produced in the past.

At present Mr. Douglass is going slowly with the development with the purpose of proving up the extent of the good showings with the idea of expanding the operation as developments justifx.

Reproperty is on the Grande Rome river slope about two miles below Grande Ronde lakes. The mine is reached over the Anthony lake road via Anthony lake.
