Location: The property is located in Wallowa County, Oregon on the Snake ~~river~~ and Imnaha rivers in sections 13, 14, 23, 24, 25, and 36, T.4N., R.48E., WM and sections 18, 19, and 30 T.4N., R.49E., W.M. *(At the mouth of the Imnaha.)*

Area: Forty nine patented claims. Taken from U. S. Mineral Land Survey No 469. La Grande land office. W.E. Adams, surveyor. Survey dated Oct. 24, 1902. Fargo Group of quartz claims, area 488.348 acres. Sheet 1. Claims known as Iowa, Grey Eagle, Butte, Mountain Side, Mother Lode, Frisco, Summit, Free Coinage, Iron King, Extension, Pier Extension, Maggie, Alice Fraction, Snake River Chief, Center, Jollie Boy, Rattle Snake, Last Chance, and Violet Claims tied to section corner common to sections 17, 18, 19, and 20. Sheet 2. Claims known as Cub, Gypsy Queen, Effie, Little Giant, Portland, Rocky, Iron Cap, Governor Lord, Delta, Governor Geer, Mountain Chief and Point. Sheet 3. Claims known as Teller Extension, Hope, Dixie, Jet, Legal Tender, Mountain Lion, Bill, Clark, Teller, Cactus, and Morning.

Fargo Group of quartz Claims No. 2. Survey No. 507 dated Oct. 11, 1902. Survey by W.E. Adams. Area 126.055 acres, in sections 13, 14, 23, and 24. T.4N., R.48E., W.M. Claims known as Evergreen, Imnaha, Stanford, Heidelberg, Oxford, Cambridge, and Daisey.

Headlight Group of Eureka Mining, Smelting and Power Co; Area 43.820 acres in sections 25 and 36, T.4N., R.48E., W.M. are sections 30, T.4N., R.49E., W.M. Survey No. 723, dated June 5, 1902. Surveyed by W.E. Adams. Claims known as Minnie, Clemons, and Head Light.

History: The Mine, a stock Company, was active between 1902 and 1912. Several hundred thousand dollars worth of work was done, but due to the difficulties involved in transportation, the sinking of the company's steam freighter and the death of their president, Mr. Harrison, work was discontinued. No work has been done since 1912. (From letter of Lester E. Brown 11/15/41 sec-tres. of Opportunity Land Co.)

Miscellaneous: The claims are inaccessible except by boat from Lewiston or by horse-back from Buck Horn Springs. The Country is rugged, and has little water except at the Snake and Imnaha Rivers.

Specimen samples furnished by Mr. Brown were chiefly magnetic. Some of the specimens contained chalcopyrite. No gold or silver was found in any of the samples.
