It is a condition of this Letter of Credit that it shall be deemed to be automatically extended without amendment from year to year from the present or any future expiration date hereof, unless at least 60 (sixty) days prior to any such future expiration date, we notify you in writing by registered mail/courier that we elect not to consider this Letter of Credit to be extended for any additional period. Upon your receipt of such notice, you may draw under this Credit by means of your draft on us at sight when accompanied by the following document:
